#### Welcome & Remarks

## **Approval of Meeting Minutes**

The minutes from the May 8<sup>th</sup> Committee meeting were reviewed by the members. A motion to approve the minutes was made by Tamy Mann, and Heather Sellers seconded the motion. Faith Power abstained from voting, as she was not present at the May 8<sup>th</sup> meeting. After a vote, the minutes were approved 6-0.

# **Updates from Professional Standards Team**

Andrea Sutton provided a brief update from the Professional Standards Team. She described the work that the Team has done regarding presenting information sessions and conducting site visits. Finally, she announced that Timika Cousins, Cori Davis, and Faith Power have all been reappointed to the Committee.

#### **Review of Accreditation Application Documents**

The Professional Standards Team asked if the Committee had any questions or comments regarding the application and site visit checklist that will be used for the upcoming accreditation round. A Committee member stated that the edits made helped to improve the documents. There were no other comments.

## **Review of Agencies for Accreditation**

Amber Stanwix and Andrea Sutton conducted the review of accreditation recommendations.

#### LAWS Domestic Violence and Sexual Assault Services

After a presentation by the Professional Standards Team demonstrating that LAWS Domestic Violence and Sexual Assault Services met all the Professional Standards, Teresa McKensie made a motion to approve the accreditation status recommendation, and Leah Kipley seconded the motion. The Professional Standards Committee voted 8-0 to grant full accreditation status to LAWS Domestic Violence and Sexual Assault Services as a dual sexual and domestic violence agency.

# First Step, A Response to Domestic Violence, Inc.

After a presentation by the Professional Standards Team demonstrating that First Step: A Response to Domestic Violence, Inc. met all the Professional Standards, Faith Power made a motion to approve the accreditation status recommendation, and Cori Davis seconded the motion. The Professional Standards Committee voted 8-0 to grant full accreditation status to First Step: A Response to Domestic Violence, Inc. as a domestic violence agency.

## Fairfax County Domestic and Sexual Violence Division

After a presentation by the Professional Standards Team demonstrating that Fairfax County Domestic and Sexual Violence Division met all the Professional Standards, Tamy Mann made a motion to approve the accreditation status recommendation, and Timika Cousins seconded the motion. The Professional Standards Committee voted 8-0 to grant full accreditation status to Fairfax County Domestic and Sexual Violence Division as a dual sexual and domestic violence agency.

During the presentation for this agency, Markella Maschas informed the Committee that Shel Douglas has resigned her position with Fauquier County Social Services. Therefore, she is no longer eligible to serve on the Professional Standards Committee.

# Family Crisis Support Services, Inc.

After a presentation by the Professional Standards Team demonstrating that Family Crisis Support Services, Inc. met all the Professional Standards, Leah Kipley made a motion to approve the accreditation status recommendation, and Heather Sellers seconded the motion. The Professional Standards Committee voted 8-0 to grant full accreditation status to Family Crisis Support Services, Inc. as a dual sexual and domestic violence agency.

#### **Selection of Next Meeting Date**

Amber Stanwix informed the Committee that the Professional Standards Team will be accepting applications for accreditation from October 7<sup>th</sup> through November 15<sup>th</sup>. The Committee agreed to meet on November 18<sup>th</sup>. This meeting will be held virtually.
