New Sexual Assault Services Program (SASP) Recipient

- DCJS awarded STEPS Domestic and Sexual Violence Services with a SASP grant using unused SASP funds from CY 2023.
- The awarded project will support sexual assault services in an underserved area of Virginia (the counties of Amelia, Buckingham, Cumberland, Lunenburg, Nottoway, and Prince Edward).
- STEPS recently reopened Madeline's House (shelter) in Farmville,
 VA. Congratulations to STEPS!



Victims of Crime Act (VOCA)

- Virginia's federal fiscal year 2024 VOCA award totals \$19,866,137, down from \$34,605,387 in FFY 2023, and is a 10-year low.
- We anticipate a similar award in FFY 2025.
- Federal Crime Victims Fund balances remain concerningly low, and there is also ongoing litigation that may impace the future of VOCA funds.

Victim Services Grant Program (VSGP) SFY 2025 (competitive)

- 1st Quarter progress and financial reports are due 10/15.
- Programs that have pending encumbrances will not be able to submit claims until the encumbrance is met.
- New Grant Orientation occurred on 7/15. A recording of the training and the grant guidelines are attached to the grant in OGMS.
- VAdata VSGP competitive specific option coming soon.

Victim Services Grant Program (VSGP) SFY 2025 (competitive)

- State funded VSGP competitive programs will NOT report in PMT. These programs will use an Excel based template that was sent via OGMS correspondence.
- Complete the status report in OGMS then attach the Excel file and submit.
- Reminder: If your grant number has an **S**, such as 25-C8631VPS, then your program is state funded.

- Federally funded VSGP competitive programs will report in PMT like in previous years – email Anya.Shaffer@dcjs.virginia.gov if you have any trouble accessing PMT or your new SFY25 award.
- Complete the status report in OGMS, attach a PDF of completed PMT data and submit – No change from previous years!
- Reminder: The victims served count starts over each year, so for this quarter, every victim served will be "new".

American Rescue Plan Act (ARPA) for Sexual and Domestic Violence Services, SFY 25

- 1st Quarter financial and status reports are due 10/15.
- Reminder: Quarterly status reports are new for ARPA.

Victim Witness Grant Program (VWGP)

Great news!

Increased SFY 2025 awards are now at the level of SFY 2023 awards.



Victim Witness Grant Program (VWGP)

 Prior to obligating or expending SFY25 grant funds approved in the state budget, grant recipients are required to allocate the additional funds by submitting a Contract Amendment. Contract Amendments to allocate SFY25 funding are due October 15, 2024.

 Grant Goals must be completed in VSDCS before submission of your first quarter SFY25 progress report.



VSDCS Enhancements

Effective with the generation of your Quarter 1, State Fiscal Year 2025 progress report:

- Progress Report view is now landscape and the five service categories are grouped together and include the current grant goals and YTD status for victims and witnesses.
- Terminology popup updates to mirror federal language.
- Removal of Individual Counseling service selection.
- New Charged Offenses added.
- Expanded special classifications selections.

- CY 2024 Annual Status Reports will be completed within the new federal web-based system.
