# Tools for Victims of Stalking

The Stalking Prevention, Awareness, and Resource Center (SPARC) offers numerous resources for victims of stalking on their website ([www.stalkingawareness.org](http://www.stalkingawareness.org)) including:

- [The Stalking Harassment Assessment and Risk Profile \(SHARP\)](#) – This free online questionnaire allows victims to enter information about their stalking experience, and SHARP then provides the victim with two reports. The first report provides the victims with a narrative of their stalking experience and a risk profile. The second report provides the victim with details about their stalking risk and safety resources and information.
- [The Stalking Victim Handbook](#) provides information so victims may better understand stalking tactics, behaviors, and risk factors. It also provides some safety planning tips and resources. It is also available in [Spanish](#).
- [The Stalking Incident and Behavior Log](#) is a form that victims can use to document the details of stalking incidents for their records or to report them to law enforcement, victim advocates, or civil and criminal court. The Spanish version of the log can be found [here](#).

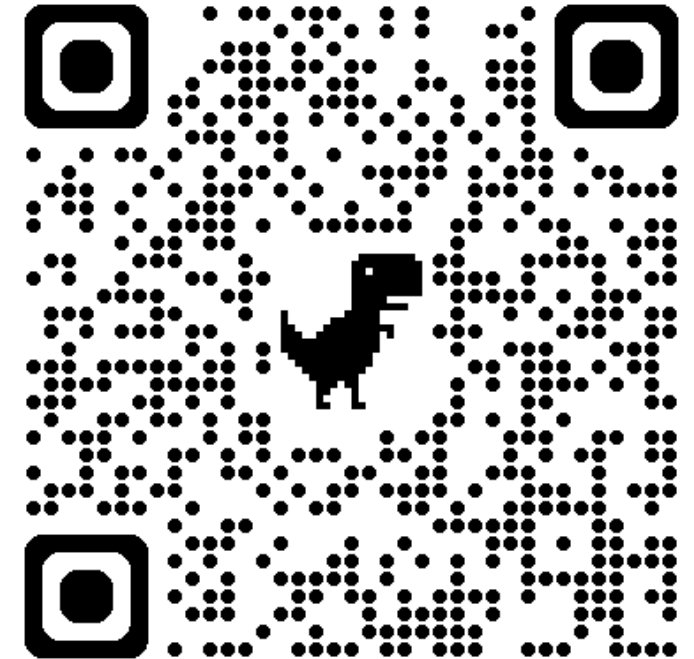

# Victims of Crime Act (VOCA) Funding

- Virginia's federal fiscal year 2024 VOCA award totals \$19,866,137, down from \$34,605,387 in FFY 2023.
- We anticipate a similar award for FFY 2025.

# VS VOCA-Supported Grants

1. Victims Services Grant Program (VSGP) (competitive)
2. VSGP for Sexual and Domestic Violence (non-competitive)

For both grant programs:

- 2nd Quarter financial and status reports are due 1/15/2025.
- DCJS will soon release guidelines for applying for continuation funding for SFY 2026. Applications will be due in early March. Only current recipients are eligible to apply.



# VS VOCA-Supported Grants

## 3. Victim Witness Grant Program (VWGP)

- 2nd Quarter financial and status reports are due 1/15/2025.
- DCJS will soon release guidance for applying for SFY 2026 continuation funding. Only current recipients are eligible to apply.
- Eight VSDCS enhancement releases are being scheduled before the close of SFY 2025. More info to come!

# Violence Against Women Act (VAWA) Funding

- Funds administered by the federal Office on Violence Against Women (OVW).
- Awards have remained relatively level from year to year.
- Virginia's FFY 2024 SASP and STOP awards:
  - ✓ SASP = \$1,034,419
  - ✓ STOP = \$4,086,790

# VS VAWA-Supported Grants

## 4. Sexual Assault Services Program (SASP)

- CY 2024 quarterly financial reports are due 1/15/2025.
- CY 2024 annual status report on-line form will open in early February. Reports are due mid-February. See email and OGMS correspondence sent 12/30/2024 for details. DCJS will enter and approve extensions for the new due date in OGMS.
- CY 2025 award letters sent in OGMS on 12/16/2024.
- CY 2025 New Grant Orientation occurred earlier today. See webinar recording and slides on the funding opportunity.

# VS VAWA-Supported Grants

## 5. Virginia Services, Training, Officer Prosecution (VSTOP)

- VSTOP Annual Reporting System will open in early February. A link will be sent for your submission.
- Reports must be submitted in the federal system by 2/21/2025.
- Review necessary trainings and resources sent via email prior to accessing the system.
- You will **no longer** be submitting a biannual report in mid-January.
- Quarterly financial reports are due 1/15/2025.

# Other Funding Sources

6. American Rescue Plan Act (ARPA) VSGP Restoration
  - 2nd Quarter financial reports and status reports are due 1/15/2025.
  - Reminder: this is the last year of ARPA funding; the grant program ends 6/30/2025.
  
7. Virginia Sexual and Domestic Violence Victim Fund (VSDVVF)
  - 2nd Quarter status and financial reports are due 1/15/2025.
  - Grantees should follow their usual reporting process.
  - Future funding updates will be communicated via OGMS correspondence.
